Benjamin Voce-Gardner, an Iraq War veteran and a former officer in the U.S. Navy Judge Advocate General's Corps, joined Zuckerman Spaeder as an associate three years

Benjamin has expertise in criminal, appellate and military law, as well as background in New York's federal and state courts. He has represented clients in a wide range of criminal matters, including financial fraud, narcotics trafficking, murder and receipt, possession and distribution of child porno-

He has both prosecuted and defended sexual assault cases in the Navy and has successfully litigated several criminal cases. When former Southern District Judge Barbara Jones, now a Zuckerman Spaeder partner, chaired the U.S. Department of Defense Response Panel and was tasked with investigating the military's handling of sexual assault, Benjamin played an instrumental role as a chief legal aide.

When deployed to Baghdad in 2008, Benjamin served as command judge advocate at the Joint Interrogation and Debriefing Center. He provided legal advice and oversight, and assisted in drafting U.S. policy regarding detention and interrogation. He also worked with American and Iraqi prosecutors to collect evidence for cases in Iraqi criminal courts.

Pro Bono/Civic Activity

Working with The Innocence Project, Melissa drafted an amicus brief supporting the release of Erskine Johnson, who claimed to have been wrongfully convicted since 1983. As a result of the brief, the Court of Criminal Appeals of Tennessee said he was entitled to a retrial on newly discovered evidence. The state did not pursue a new trial and Johnson was released in 2012.

Melissa represented an indigent individual from Liberia who was extradited to the U.S. on conspiracy to import narcotics charges. Based on materials received through the Jencks Act, the U.S. government dropped the charges. She has also represented individuals seeking political asylum through The City Bar Justice Center.

Melissa serves on the New York State Pattern Jury Instructions Subcommittee of the Commercial and Federal Litigation Section of the New York State Bar Association.
